Regular Board Meeting Notes November 20, 2025

Sandy Guldman called the meeting to order via Zoom and in person at 7 PM at the Club Room, The Terraces, 82 Camellia Circle in Larkspur. Other board members also present: Charles Kennard, Laura Lovett, Alycia Matz, Dayna Quick, Nick Salcedo, Barbara Salzman, and Ann Thomas. Guests: Jason Brodersen, Dennis Portnoy.

Introductions. Board members and guests introduced themselves.

Approval of October 19, 2025 Minutes. M/S (Charlie/Sandy) and approved as submitted.

Financial Reports. Total assets as of 10/31/25 were \$139,531.96 including \$126,122.96 in a Certificate of Deposit. In addition, Friends has a contract for \$59,000 to compensate for impacts to the lagoon from repair work that was done there.

Website Update. Friends has received an offer from GoDaddy to provide WordPress maintenance services, including updating as needed, SSL certificates, and backup for 10 years for \$1075. Sandy will follow up on this offer which would cost less than purchasing the SSL certificates and backup separately from GoDaddy.

M/S/P (Laura/Charlie) to authorize \$1075 for the GoDaddy WordPress management.

Creek Chronicles. Charlie reported that about six feature articles are in the works for the Winter issue, along with the Thank You list and Calendar.

Possible New Project: Multi-Use Path Modification. Sandy suggested Friends consider a future project to improve the multi-use path between College Avenue and the RVSD Pump Station. It would include widening of the approximately 100-foot section downstream of Stadium Way, moving the main MUP to the left bank between Stadium Way and College Avenue, and providing ADA-compliant approaches to the Stadium Way end of the bridge and the crossing of College Avenue. If this were done, the Stadium Way bridge would mainly serve KMS. And, importantly, relocation of the MUP to the left bank would open up the right bank for habitat restoration-enhancements and flood risk mitigation.

Reports

Larkspur Library. Laura reported that the habitat garden designed by Refugia Marin for the new library, will be put out to bid in December. The planned garden would be about 6,000 square feet in size and showcase California native plants.

Ecology Study Area. Materials and plants for the COM project are temporarily stored at the ESA.

Lower COM Habitat Restoration. Work is progressing well, with planting underway. Installation of fencing is expected to begin on 11/24/25.

Saunders Bridge Replacement. There is no word of funding for this project at this time.
